## **Helpful Hints to Complete the Parental Guaranty**

### **Why do we need to provide a Parental Guaranty?**

Most students have no means of paying for their rent or established credit. As a parent you are acknowledging with this document that you are securing the lease and understand the obligations.

### **Why does it need to be notarized?**

This is a legally binding obligation and becomes part of the leasing documents.

### **What information will we need to complete the top half?**

- Your child's full name
- The mailing address of the property your child is leasing
- The entire amount of monthly rent – NOT just your child's portion
- The leasing dates

### **Do we need to complete both Mother/Guardian & Father/Guardian Information?**

Yes, in most cases – If you file your taxes jointly then both parents can be listed on the same form. If parents file their taxes separately, then two forms can be completed with each individual's information.

If a parent or guardian is deceased, please make note on the form so Legacy staff know you didn't just forget to fill it out.

If circumstances are unique to you, please contact us before completing the form for additional instructions.
