

Furniture Hand Me Down Guidelines

The signed lease states the unit must be completely empty at the expiration of the lease. Any items left behind will be considered Abandoned Property and the security deposit may be assessed for removal and storage.

What if I want to leave items for the next tenant?

Tenants must get prior *written* approval from the staff at LRPM. IF you do not have approval and items are left behind they will be considered Abandoned Property and the security deposit may be assessed for the removal and storage of those items.

Timeframe: The request must be made to LRPM no later than July 15, 2021 in writing, email is sufficient.

Items allowed:

Couch
Desk
Bed frame
Table & Chairs
Mini refrigerator - must be empty & unplugged

Items NOT allowed:

Personal belongings
Clothing
Kitchen items & accessories - dishes, pots & pans, coffee pots, utensils, etc.
Food – please donate them to the State College Food Bank
Electronics
Cleaning products – we throw away all open products

How to leave them:

Items must be moved into the center of ONE room.
Items must be covered with a tarp, plastic or sheets.

Please be advised, items left in the units are not the responsibility of Legacy Realty & Property Management. Tenants leave items at their own risk. During the Turnover period the units are accessed by multiple staff and subcontractors to prepare them for the next leasing year.

All tenants **MUST** sign and return the attached waiver along with their request.
